ECAT STATEMENT OF COMPLIANCE

- 1) I have read this document and am familiar with the ECAT Programming Policy
- 2) I am thoroughly familiar with the content of this program. I hereby state that it does not contain:
 - a) Obscene material.
 - b) Commercial advertising or commercial solicitation of any kind.
 - c) A lottery, or any advertisement or information concerning any lottery.
 - d) Any promotional material concerning products or services presented for the purpose of any solicitation of money or other things of value, unless specifically exempted under the terms of this document.
 - e) Any material which constitutes libel, slander, invasion of privacy or publicity rights, unfair competition, violation of trademark or copyright, or which might violate any local, state or federal law.
 - f) Indecent exposure as defined by local, state or federal law.
- 3) I assume full responsibility for the content of all program material I am submitting for cablecast and ensure that such program material does not violate any right of any third party.
- 4) I have obtained or, before the programming material is cablecast, will obtain, all approvals, clearances, licenses, etc. for the use of any program material to be cablecast, INCLUDING BUT NOT LIMITED TO approvals by broadcast stations, networks, underwriters, music licensing organizations, copyright owners, performers' representatives, all persons appearing in or referred to in the program material, and any other approvals that may be necessary to transmit program material over ECAT. In the event of a dispute or challenge, ECAT may require evidence of clearances prior to further program distribution.
- 5) I indemnify and hold harmless the Easton Community Access Television Inc., its directors, officers and staff, against any claims arising out of any use of this program material I submit for cablecast or for any breach of this Statement of Compliance, INCLUDING BUT NOT LIMITED TO any claims in the nature of libel, slander, invasion of privacy or publicity rights, noncompliance with applicable laws and unauthorized use of copyrighted material. I understand that I may be criminally or civilly liable for performing or producing such material which is cablecast.
- 6) I agree that I shall not represent myself or any other person involved in community access cablecasting or productions as an employee, representative of ECAT of the local cable company/companies, or the Town of Easton.
- 7) I shall not use ECAT channels, equipment or facilities for any financial gain or other commercial purposes. I understand that programming produced with ECAT equipment MUST appear on the ECAT public access channel.
- 8) I understand I am required to disclose on this Playback Form & Statement of Compliance whether any program submitted contains adult content, and I agree that such programming will be aired on ECAT between the hours of 11pm and 5am.
- 9) I understand that false or misleading statements made in this Application for Cablecast & Statement of Compliance are grounds for forfeiture of the right to use ECAT public access equipment and facilities.
- 10) I understand that my program(s) will be cablecast based on information provided on the Playback Form & Statement of Compliance. Any errors or inconsistencies may result in aborted playback. Repeat violations may result in denial of my right to cablecast on ECAT.

ECAT, the Town of Easton, and the cable operator are not responsible for the content of the programming shown on the community cable channels or on ECAT's web site. The responsibility and liability for such content lies solely with the person who submits the programming and signs the Cablecast Agreement. ECAT, the cable operator, and the Town of Easton assume that the producer or the party who submits the programming and signs the Cablecast Agreement has obtained all necessary releases and clearances. The individual who submits the programming may be asked to furnish proof that proper releases and clearances have been obtained.

I have read this form, understand it, and agree to the policies of ECAT. I agree to hold harmless the cable operator, the Town of Easton, Easton Community Access Television, its directors and employees (and their successors) from any liability, loss, claim, cost or damage of any nature whatsoever which may arise by reason of any claim that any material produced, cablecast, or disseminated by me infringes or violates any rights of any person or organization.
